

The above candidates are advised to report at Regional Office ESIC, Panchdeep Bhawan, Sarvodaya Nagar Kanpur on 19.09.2018 between 09:00 A.M. to 05:30 P.M. for document verification alongwith the following documents in original for verification.

Important Note:

- The above candidates must bring all original documents in support of their eligibility criteria for the concerned post at the time of document verification. Two sets of self-attested documents in support of their educational qualification are also required. The following additional documents are required at the time of Document Verification.
 - Print of Online application.
 - Copy of Admit Card/Call Letter for document verification.
 - Copy of Photo Identity documents viz- Aadhar Card, Pan Card, Driving License, Voter Card or any others photo identity proof.
 - Certificate in proof of Age/ Date of Birth Certificate.
 - Caste Certificate (SC/ST/OBC) issued by appropriate authority (in case of OBC Category- Latest OBC Certificate in prescribed proforma alongwith Form of Declaration as appended on uploaded at Annexure-A and Annexure-B). The candidate must bring the latest OBC certificate in the prescribed format issued by the Competent Authority.
 - Disability Certificate in case of person with disability (PWD).
 - Discharge certificate/book alongwith relevant documents in case of a candidate belonging to Ex-Serviceman category.
 - No Objection Certificate from the parent Department, if employed at present in any Government Office, Autonomous Body, Statutory Body or Public Sector Undertaking.
 - Candidates seeking age relaxation as Government Employees/ESIC Employee shall have to produce Service Certificate for verification.
 - Two recent passport size photographs.
 - Affidavit required in case of mismatch of the name/ father's name/Surname etc. on various documents.
 - Two sets of photocopy of all required documents.
- Calling of candidates for documents verification does not confer any right upon candidate for his/her appointment to the concerned post. The candidature of candidates is purely provisional. If at any stage, it is found that he/she is involved in any malpractices in the examination process, his/her selection/appointment shall be summarily cancelled and appropriate legal action shall be initiated against his/her.
- Candidate will have to make their own arrangement of stay and no TA/DA is admissible for the same.
- The instructions for document verification to above provisionally eligible candidates is also being sent through their mailing address.
- While utmost care has been taken for preparing the list of provisionally eligible candidates for Document Verification, but inadvertent human errors cannot be overruled.
